Format

- Up to eight teams.
- Four 70 minute stop time games (three 15 minute periods + a 3 minute warm up).
- Body Contact.
- A minimum of one ice cut will take place between each game.

Awards

- Medals for Gold/Silver/Bronze
- 1st Place nameplate on our perpetual trophy.

Souvenirs

- All players will receive a special tournament souvenir.

Team Fee – \$1,200 Due by December 6, 2017 – non-refundable unless tournament is cancelled.

- Register by mail with check payable to KIS.
- **There will be a \$150 penalty for all fees that arrive after the deadline. Teams will not be allowed on the ice until the penalty fee is paid.**

Paperwork – Due by January 10, 2018

- USA Hockey team roster + BCCIA/KIS Waiver Release + BCCIA/KIS Photo Release for each on ice participant.
- **Late paperwork can result in forfeiture of the first game.**

Insurance and Guidelines

- All players and coaches must be currently registered with USA Hockey and be members in good standing of their local and state hockey affiliates.
- USA Hockey Rules and Regulations will apply.

Changing Facilities

- KIS has two changing facilities. Teams will need to pay close attention to their game times and arrive at the arena dressed and ready to lace up their skates as there won't always be time to get dressed in a changing room.
- Equipment cannot be left in changing rooms between games.

Required Volunteers

- Home teams will provide an adult (18+ years of age) to keep score and two adult penalty box assistants.
 - These volunteers need to check in at the Skate Shack 15 minutes prior to game time.

Weather Related Issues

- The Bill Collier Community Ice Arena is a covered outdoor arena and we are sometimes blessed with winter storms. We skate rain, shine, or blizzard. **Please allow ample travel time as the start times will not be altered for team members who are late.**
