



Fifth Annual Collier Challenge Cup

January 13th, 14th, 15th, and 16th, 2012

Format

- **Bantam/Midget - High School Teams** – Eight Team Tournament. Teams must use their regular season roster.
- **Games**
 - Each team is guaranteed four 70 minute stop time games (three 15 minute periods plus a three minute warm up).
 - Top four teams will get one to two additional games.
 - A minimum of one ice cut will take place between each game. If time and weather permit, two cuts and at least one flood will take place between games.
- **Awards**
 - Medals for 1st, 2nd, and 3rd place teams
 - 1st place – nameplate on our perpetual trophy
- **Logo Merchandise**
 - All players will receive a tournament patch
 - Tournament t-shirts can be ordered separately; order forms/payments must be turned in with the tournament balance on or before November 30th. Please see T-Shirt Order Form.
- **Fees**
 - \$1299 per Team
- **Insurance and Guidelines**
 - All players must be currently registered with USA Hockey and be members in good standing of OSHA and their local hockey organization.
 - USA Hockey Rules and Regulations will apply.
- **Changing Facilities**
 - KIS has two changing facilities. Teams will need to pay close attention to their game times and arrive at the arena dressed and ready to put their skates on as there won't always be time to get dressed in a changing room. PLEASE do your best to share these rooms.
 - Please do not leave any equipment in the rooms between games.
- **Weather Related Issues**
 - The Bill Collier Community Ice Arena is an outdoor arena and we are sometimes blessed with winter storms. We skate rain, shine, or blizzard. Please allow ample travel time so the players are dressed and ready to hit the ice fifteen minutes before their scheduled start time. The game clock will start ticking at the designated game time whether the teams are on the ice or not; in the event the BCCIA needs to make an additional run with the Olympia, the game schedule will be altered. The game schedule will NOT be altered for team members who are late.

- **Deadlines for Fees and Paperwork**

- **R.S.V.P.** – As soon as you know you would like to participate!
 - Participation is limited to the first eight teams who indicate in writing that they would like to participate in the tournament; a waiting list will be started for the remaining teams.
 - Your place is secure once your deposit, balance, and all paperwork have been received of KIS by the deadlines listed below.
- **Deposit Due** - On or before Wednesday, November 9, 2011:
 - \$339 non-refundable deposit per team must be received by KIS/BCCIA
 - This deposit is completely non-refundable/non-transferrable unless the tournament is cancelled by KIS/BCCIA.
- **Balance Due** - On or before Wednesday, November 30, 2011:
 - \$960 non-refundable/non-transferrable balance per team must be received by KIS/BCCIA.
 - T-Shirt orders/payment per team must be received by KIS/BCCIA.
- **Paperwork Due** – On or before Wednesday, January 4, 2012:
 - The following paperwork must be received by KIS-
 - USA Hockey Team Roster
 - KIS/BCCIA WAIVER RELEASE and PHOTO RELEASE
- **Late payment; and late paperwork** –
 - \$100 late fee will be assessed for all late payments and/or paperwork. No exceptions.

Required Volunteers

- **Scorekeepers, Penalty Box Assistants, Hospitality Table –**

- Home Teams will provide two scorekeepers and two penalty box assistants (adults) for all games except the Championship Game
 - Scorekeepers and penalty box assistants must check in at the Skate Shack main window at least 15 minutes before the start of the game.
 - Each team must provide back-up scorekeepers in the event the main scorekeepers cannot keep their commitment.
- KIS team will provide two scorekeepers and two penalty box assistants (adults) for the Championship Game
 - Scorekeepers and penalty box keepers must check in at the Skate Shack main window at least 15 minutes before the start of the game.
 - Each team must provide back-up scorekeepers in the event the main scorekeepers cannot keep their commitment.
